

INTERNAL REGULATION of the CAMPSITE of the PETIT PONT

(According to Decree of February 17th, 2014).

I- GENERAL CONDITIONS

1 °) Conditions of membership : to be admitted penetrating, settling down or staying on a campsite, it is necessary to have been authorized by the administrator or his representative there. It has for obligation(bond) to watch the good behavior(performance) and the good order of the campsite as well as the respect for the application of the present internal rules. The fact of staying on the campsite implies(involves) the acceptance of the capacities(measures) of the present regulation(payment) and the commitment to conform to it. Nobody can take up residence there.

2 °) Police formalities : the minors not accompanied with their parents will be admitted that with a written authorization of these.

In application of the article R.611-35 of the code of the entrance and the stay of the foreigners and the right of asylum, the administrator has to make fill and sign by the foreign customer, from his arrival, an individual index card of police. She has to mention in particular the name and the first name, the date and the place of birth, the nationality and the usual place of residence. The old children under age 15 can appear on the index card of one of the parents.

Every person that must stay at least one night in the campsite beforehand has to present to the administrator or his(her) representative its identity cards and fill the formalities required by the police

3 °) Installation : the outdoor accommodation and the material relative to it must be installed in the location indicated according to the directives given by the administrator or his representative.

4 °) Reception :

Open from 09:00 am till 12:30 am and from 3:00 pm till 7:00 pm in season.
Open from 10:00 am till 12:00 am and from 3:00 pm till 6:00 pm in the off season. Closed On Sunday afternoon in the off season.

We shall find in the reception all the information on the services of the campsite, the information on the possibilities of provisioning, the sports facilities, the tourist wealth of neighborhood and diverse addresses which can

turn out useful. A system of collection and treatment of the complaints is kept at the disposal of the customers. The complaints will be considered only if they are signed, dated, so precise as possible and relating to relatively recent facts.

5 °) Display : the present internal rules are posted in the entrance of the campsite and in the reception. He(it) is put back to the customer in his(its) demand.

For the classified campsites, the category of classification with the mention tourism or leisure activities and the number of location tourism or leisure activities are posted.

The prices of the various services are communicated to the customers in the conditions fixed by order of the Secretary loaded the consumption and available for consultation in the reception.

6 °) Modalities of departure : the customers are invited to warn the reception of their departure from the day before this one. The customers intending to leave prematurely opening of the reception have to make the day before the payment of their stay.

Fees are paid to the reception. Their amount been the object of a display in the entrance of the campsite and in the reception. They are due according to the number of nights crossed on the ground.

7 °) Noise and silence : the users of the campsite are insistently asked to avoid any rumours and discussions which could hamper their neighbors. Acoustic appliances must be accordingly settled. The closures of car doors and safe must be as well discreet as possible. Dogs and other animals must be never left free. They must not be left with the campsite, even locked in the absence of their masters who are civilly liable there.

The administrator assures the tranquillity of his customers by fixing schedules counterparts which the silence must be total or between 11 pm and 7:45 am.

8 °) Visitors : having been authorized by the administrator or his representative, the visitors can be admitted in the campsite under the responsibility of the campers who receive them. The camper can receive one or several visitors in the reception. The services and the installations of campsites are accessible to the visitors (except swimming pool). However, the maybe paying use of these equipments according to a price list which has to be the object of a display in the entrance of the campsite and in the reception. The cars of the visitors are forbidden in the campsite.

9 °) Traffic and car park of vehicles: inside the campsite, vehicles have to run to a speed limited to 10 kph. The traffic is forbidden between 11 pm and 7:45 am. Can circulate in the campsite only the vehicles which belong to the campers staying there. The car park is strictly forbidden on locations usually occupied by the accommodations unless a parking space was planned for that purpose. The car park does not have to hinder the traffic nor prevent newcomers' installation.

10 °) Holding and aspect of the installations : each has to refrain from any action which could damage the cleanliness, the hygiene and the aspect of the campsite and its installations, in particular sanitary. It is forbidden to throw waste water on the ground or in gutters. The customers necessarily have to empty their waste water in the installations planned for that purpose. Household waste, waste of all kinds, papers, must be put down in trash cans. The wash is strictly forbidden outside tubs planned in this use. The clothesline of the linen will be made if necessary in the common hairdryer. However, he is tolerated until 10 hours near the accommodations, on condition that he is discreet and does not hamper the neighbors.

He will never have to be made from trees. Plantations and flower arrangements must be respected. It is forbidden to crash nails in trees, to cut branches, to make plantations. It is not allowed to bound the location of an installation by average staffs, nor to dig the ground. Any repair of degradation appointed to the vegetation, to the closes, to the ground or to the installations of the campsite will be chargeable to his(her) author. The location which will have been used during the stay must be maintained in the state in which the camper found him(it) in his entrance to places.

11 °) Security

A) Fire : the open fires (wood, coal, etc.) are strictly forbidden. Stoves must be maintained in good working order and not be used in dangerous conditions. In case of fire inform immediately the direction. Fire extinguishers are usable in case of necessity. A first-aid kit of first urgency is in the reception.

B) Flight : the direction is responsible for objects put down to the office and has a general obligation of surveillance of the campsite. The camper keeps the responsibility of his own installation and has to indicate to the person in charge the presence of every suspect person. The customers are invited to take the usual precautions for the protection of their material.

12 °) Games : no violent game, or annoying, can be organized near the installations. The meeting room cannot be used for the animated games. The children will always have to be under the supervision of their parents.

13 °) dead Garage : he can be left by material not occupied on the ground, that after agreement of the direction and only in the indicated location. A royalty, the amount of which will be posted to the office, will be due for the " dead garage ".

14 °) Breach of the internal rules : in case a resident one would disrupt the stay of the other users or would not respect the capacities of the present internal rules, the administrator or his representative can orally or in writing if he considers it necessary, to give a formal notice the latter to stop the disorders. In the event of infringement grave or repeated to the internal rules and after formal demand by the administrator to conform to it, this one can cancel the contract. In the event of infringement penal, the administrator can appeal to law enforcement.

II - PARTICULAR CONDITIONS

1 °) Breach of the internal rules : the internal rules of the campsite apply to all. Every customer makes a commitment to conform to it. In case of failure to respect this one, the direction can ask the customer concerned to leave the campsite without any repayment of all of the reserved stay.

2 °) Fees : the arrivals and the departures for the campers are made every day of the week. The departures have to be made at the latest in 12H00. After this deadline, will be counted an additional day.

3 °) Insurance : the users of the campsite make a commitment to be covered by a third-party insurance. The documentary evidence of this insurance must be presented to the reception at the latest during your arrival. If such was not the case, you will have to adhere **NECESSARILY** to the insurance of the FFCC or others.

4 °) Smoking ban in the rents : he(it) is no smoking in mobile homes. Ashtrays are at arrangement to smoke outside.

5 °) Barbecues : the use of the electric or gas barbecues is recommended. However, the use of the charcoal barbecues is tolerated, subject to one very great caution and **only from 11 am till 10 pm.**

6 °) Respect for the neighbors : the outside lights of the rents will be put out from 11:00 pm not to hamper the other users of the campsite.

7 °) Animals : animals are authorized in the campsite under certain conditions. They must all be kept on a lead and should not remain alone on locations nor in the rents (plan covers to put on pillows and beds of the mobile home). Animals are forbidden in mobile homes double roof slope. Cats are forbidden in all the mobile homes. Any possible excrement will have to be collected by their owner. He is compulsory to supply upon your arrival, the health record up to date in particular as regards the vaccination against the antirabies. The dogs of 1^{ère} and 2nd category as well as the big and/or big dogs are forbidden in the campsite.

8°) Swimming pool : the swimming pool is strictly reserved for the clientele of the campsite. His(her,its) access is free. A bracelet a person, compulsory to reach the swimming pool, will be gracefully handed on arrival. The lost bracelets will be charged 6 Euros. The clientele has to conform to the payment registered on the entrance of the swimming pool. It is forbidden within the swimming pool to run, to jump and to use accessories (balls, masks, lap inflatable buoys). The wearing of the swimsuit is compulsory (pair of shorts and boxer shorts forbidden). For safety reasons, the child has to be under the responsibility and the surveillance of an adult. The bathing is not watched. The access of the swimming pool is strictly forbidden the not accompanied children. Opening hours are of 10:30 am

9°) Visitors : the access the swimming pool is FORBIDDEN them.

10 °) Security measures and of risk prevention : these measures are posted in the welcome and must be respected by the vacationers.
