

CAMPSITE OF the PETIT PONT ***
GENERAL TERMS OF SALE RENTAL

By making a request of stay and by making a rent of mobile home, you take the commitment to respect the dates of stays as well as the dates of payment. The reservation becomes firm only in the reception of the deposit and the return of the rental agreement signed by 2 parts. A copy of the contract will have returned to you to confirm your reservation. The definitive decision of the acceptance of the rent depends only on the CAMPSITE. The paid deposit will immediately have returned to you if the request of reservation could not be satisfied. In case of directly on-line reservation on our web site, the validation of general terms of sale amounts to the signature of the contract rent after acceptance of the reservation by the direction.

-STAY: for the rents to the week, the arrivals take place on Saturdays from 15 hours and the departures on Saturdays before 10 am. For short-term leases, about is your days of arrival and departure and according to the availability, schedules are identical. In season, the office is opened from 9:00 am till 12:30 am and from 3:00 pm till 7:00 pm. Off season, the office is opened from 10:00 am till 12:00 am and from 3:00 pm till 6:00 pm and is closed on Sunday afternoon.

-PAYMENT OF the STAY: a 30 % deposit is to be settled during the reservation and the balance at the latest the day of the arrival. -LATE ARRIVAL: the reserved rent is retained from 3:00 pm the day indicated on the contract till 7:00 pm. If the Tenant does not arrive within the time limits allowed, and did not get in touch with the Direction, he loses the right for the installation in the mobile home reserved for him, and the already paid amounts will not be restored to him. The booking contract will then be cancelled. The Customer will then have to get in touch with the Insurer (if he subscribed to the proposed insurance contract). The late arrival becomes then a cancellation of stay.

-CANCELLATION AND INTERRUPTION OF STAY: the assurance cancellation / interruption of stay is only signed at the time of the reservation. It is strongly recommended (not compulsory). A-CANCELLATION: 2 possible cases

- until 30j before the arrival: 100 % refund - of 14j in 8j before the arrival: 10 % refund

By making a request of stay, you take the commitment to respect the dates of stays. The dates of reservation will correspond to the dates of invoicing. The reservation of location is made by means of a voucher of reservation which you return us accompanied with a 50-€ sum (39 € of deposit and 11 € of cool of management / reservation). The reservation becomes firm only in the reception of the deposit and the return of the voucher of reservation signed by both parts. The definitive decision of the acceptance of the reservation as well as the allocation of locations depends only on the CAMPSITE. The paid deposit will immediately have returned to you if the request of reservation could not be satisfied.

STAY

The arrivals and the departures are made every day of the week. The departures have to be made at the latest in 12H00. After this deadline, will be counted an additional day. In season, the office is opened from 9:00 am till 12:30 am and from 3:00 pm till 7:00 pm. Off season, the office is opened from 10:00 am till 12:00 am and from 3:00 pm till 6:00 pm and is closed on Sunday afternoon.

PAYMENT of the STAY

The balance of the stay is made at the latest the day of your arrival. **BE CAREFUL, NO PAYMENT BY EVERY WILL NOT BE ACCEPTED 30 DAYS BEFORE YOUR STAY.**

LATE ARRIVAL
