Failed Duet: for 2 grown-up bikes (26 inches) rented together over 1 week, reduction by 5 % on the rent.

Failed Family: for 4 bikes rented together over 1 week, reduction by 10 % on the rent.

Description:

Bikes (except the model 14 inches) are all equipped for a daily and urban use: lighting, bell and anti-theft device.

General conditions of rent :

- The tenant declares to have no medical contraindication and to be capable of the practice of the bike.
- An ID card is required for any rent.
- The minor has to present an authorization written and signed by his parents or quite other responsible person.
- The pledge by bike (in check or cash) is always demanded. She can serve on no account to cover a continuation of rent. She is returned during the return of bikes and accessories.
- It is possible to reserve weekly according to the conditions specified on the form of reservation (make the demand).
- The rent is payable in the provision of the bike.
- The schedules of office are from 9 am till 12 am and from 3 pm till 7 pm. The return is made at the latest 30 minutes before the closure.
- For any return except deadline will be charged a whole day. Every begun day must be paid.
- For period from Juillet 01th till August 26th, 2017, for reasons of practicality, the tenants of bikes ayants taken a rent of mobile home will arrange bikes that from Saturday, 17 a hour and will return them on Fridays before 7 pm.
- The tenant makes a commitment to use the cycle and the accessories carefully and to provide in his maintenance. He will have to return them to the renter out in the same state in which they were taken: any breakage or degradation will be charged according to the table posted in the reception.
- The tenant declares to have subscribed in a private capacity to a third-party insurance covering him in particular in case of custom of cycles. In defect, he would not know how to blame for the absence of this personal guarantee the renter out.
- The renter out is not insured for the flight of the rented cycles.
- A declaration in case of flight or of accident must be made at once in services of police or gendarmerie. The renter out must be informed at the same time. The tenant or his insurance will have to repair the damage undergone by the renter out (replacement value of the cycle, the accessories and commercial damage). In that case, (or) pledge (s) will stay (have) acquired to the renter out in account and to cost on the repair of its damage.
- The tenant is personally responsible for any offence against the Highway Code and is responsible also always for physical, material and immaterial injury which he causes on the occasion of the use of the rented cycle of which he is given custody (Article 1383 and 1484 of the Civil code).
- A fixed immobilization of the cycle will give the right on no account to damages for prevention of enjoyment. No repayment of rent will be made.
- It is forbidden to modify the rented bike, to make important repairs, to roll on beaches, to sublet or to lend, to transport a passenger other one than a very young child on condition that is installed an approved seat, to prolong the rent without preliminary agreement. In this last case, the applied price list would be the one of the cycle and the accessories, in the day, multiplied by 3.
